# Disabled Veterans' Real Estate Tax Exemption Program


- Under 51 Pa.C.S. 8904(1), the State Veterans Commission adjusts the income levels for determining need for the Disabled Veterans' Real Estate Tax Exemption program based on the change in the Consumer Price Index in the preceding two years.
- For the last two years, DMVA has applied a rebuttable presumption of need if the applicant's income is \$81,340 or less.

# Disabled Veterans' Real Estate Tax Exemption Program

- Based upon current CPI data (through October 2012), the income level would change by 4.89% to **\$85,320**.
- The CPI report for November 2012 (available December 15) is needed to complete the calculation.
  - The CPI may change by a few tenths of one percent based on recent monthly changes.
- The SVC is asked to approve the new rebuttable presumption income level (\$85,320 plus or minus the percent of change in November 2012) and authorize publication of a notice of the change effective January 1, 2013.








# Blind Pension




# Paralyzed Pension \$455,000




