The State Veterans' Commission (SVC) meeting was called to order by Chairman Brenner. The meeting was opened with an invocation and the recital of the Pledge of Allegiance.

<u>Awards:</u> Major General Randall Marchi presented the Pennsylvania Commendation Medal to outgoing Member at Large - Mr. Edward Worjanaroski for his service on the State Veterans Commission.

Remarks by The Deputy Adjutant General - Army, Major General Randall Marchi: Major General Marchi provided the Commission members an update on the Pennsylvania National Guard current unit mobilizations, total deployments and future deployments.

Remarks from Mr. Gary Devansky, Director, Coatesville VAMC: Mr. Devansky provided the Commission an update on VISN4.

Review and Approval of April 5, 2013 Meeting Minutes: Vice Chairman Hawk stated that Commander Ryersbach was not present at the April 5, 2013 meeting. Commander Iacavazzi made a motion, seconded by Commandant Corley, to approve the April 5, 2013 meeting minutes with the requested change. Motion carried.

Chief Counsel Update by Mr. Dennis Guise: Mr. Guise briefed the Commission on the Veterans Trust Fund and the Disabled Veterans' Real Estate Tax Exemption Program Rebuttable Presumption standards. DMVA received a request that the Commission reconsider new standards and delay the effective date. A motion was made by Commandant Corley to defer the effective date to January 2014. The motion was seconded by President Haberkorn. Motion carried. Mr. Guise also extended an invitation to the committee to attend the Scotland School for Veterans Children State Historical Marker Ceremony on Saturday July 13, 2013 at 2:00 pm at the Scotland School Auditorium.

Office of Policy and Legislative Affairs Update by Mr. Dusty Durand: Mr. Durand briefed the Commission on the following topics:

Office Administration Update by Ms. Debbie Stubljar: Ms. Stubljar briefed the Commission on the Honoring our Veterans License Plates. She also noted that the recent state budget did not include Pension Reform. Ms. Stubljar informed the Commission of her pending retirement and announced Ms. McPherson as her replacement.

Homes Update by Mr. Andrew Ruscavage: Mr. Ruscavage provided the Commission a Homes' update. The overall occupancy average is 90 percent. For Nursing Care beds, the overall average is 92 percent. For Personal Care/Domiciliary beds, the overall average is 81 percent. He also advised that the licensure status in each of the homes was current and in compliance with all legal standards. Mr. Ruscavage also briefed the Commission on State Veteran's Homes Week and informed the commission of the wide array of activities that would take place throughout the various Veterans' Homes during the week-long celebration.
