AGREEMENT AND RELEASE

Whereas, the Adjutant General of Pennsylvania has granted authority to engage in wood gathering activities in limited areas of Fort Indiantown Gap through its officers and agents, I accept the limited use of Fort Indiantown Gap property entirely upon my own risk and responsibility and therefore hold the United States, the Commonwealth of Pennsylvania, and its officials and agents acting officially or otherwise, harmless from any claims, damages, actions or causes of action on account of my injury or death, or on account of any and all property damage of whatsoever character or description which may be sustained by me incident to my use of the facilities of Fort Indiantown Gap.
3. It is understood that the United States and the Commonwealth of Pennsylvania, shall not be held responsible for any damage to my private property or for any injuries I may suffer while engaged in firewood gathering activities on Fort Indiantown Gap. I agree to render payment sufficient to repair/replace any and all damage to land, structures, natural resources, or other facilities on Fort Indiantown Gap.
4. All users must carry their issued Fort Indiantown Gap personal authorization and display their vehicle permit on the dash while in the firewood yard on Fort Indiantown Gap, and produce upon demand by any law enforcement officer or individual who provides identification as an official of Fort Indiantown Gap. All users are required to comply with the provisions of Fort Indiantown Gap firewood program, as well as all applicable federal, state, and local laws and regulations. Failure to do so will result in users being disqualified from the firewood program.
5. I hereby verify that I fully understand my responsibilities pertaining to outdoor recreational activities on Fort Indiantown Gap and that all information provided is accurate.
