

TUNNEL TO TOWERS OVERVIEW

On **September 11, 2001**, firefighter **Stephen Siller**, was on his way to play golf with his brothers when he learned that a plane hit the North Tower of the World Trade Center.

Stephen called his wife Sally and asked her to tell his brothers that he would be late. He returned to **Squad 1** to get his gear.

Stephen drove his personal truck to the **Brooklyn Battery Tunnel**, but it had already been closed for security purposes. Determined to carry out his duty, he strapped 60 lbs. of gear to his back and raced on foot through the **Tunnel to the Twin Towers** to save others. Stephen died in the collapse of the South Tower.

It is in Stephen's honor that we follow in his footsteps endeavoring to "do good" and make a positive and lasting impact in the lives of others.

HOMELESS VETERAN PROGRAM OVERVIEW

- The Tunnel to Towers Homeless Veteran Program seeks to eradicate veteran homelessness <u>nationwide</u>.
- With over 33,000 veterans experiencing chronic homelessness, we understand that this is no easy task.
- Simply housing an unhoused veteran is not enough to make a substantial difference in their lives.
- In order to effectively rehabilitate and reintegrate our veterans back into society, we must also provide a platform where they have ready access to a wide range of needed services, geared towards diagnosing and solving root causes of their housing insecurity.
- Their specific emotional, financial, and physical issues must be addressed.
- Our team has created a two-pronged model to address this tremendous problem...

NATIONAL CASE MANAGEMENT NETWORK

In 2023, the Homeless Veteran Program's National Case Management Network provided over 3,000 veterans with housing assistance and supportive services, in addition to almost 1,000 children.

This number will grow exponentially in the years to come as we grow out our team, strengthen our relationships across the country, and form strategic alliances with other organizations in the space.

Each Veterans Village will have a satellite office to further assist veterans and families not physically living at the site.

- Opening Fall, 2024













GI Bill®

The Veterans/Military Education Division of the Pennsylvania Department of Education has been designated by the Governor of the Commonwealth of Pennsylvania as the State Approving Agency for Training of Veterans/Eligible persons and reservists in the field of institutional training, correspondence training, flight training, apprenticeship training, and other on-the-job training.

Updates

- Risk-Based Survey Data Triggers revised per Congress in January 2024
- Supervisory Visits reinstated in January 2024
- Uniform Application Implemented in February 2024 updated version to be released in April 2024

Challenges/Barriers

- Moving targets, changing forms, and frequently changing guidance have resulted in slower processing times as our advisors and our SCOs train and adapt.
- Mid-Contract Year Change from 2-1 RBS to Supervisory Visits ratio resulted in significant increase in travel that was not budgeted.
- Staffing 2 retirements, 1 interagency transfer, & 1 military deployment in past 6 months



Education Assistance and Military Family Educational Programs

- Provide educational assistance to eligible members of the PA National Guard (EAP) and qualifying family members (MFEP)
- MFEP requires additional 6-yr service agreement with the PANG

Updates

- The lesser of 100% of the tuition plus technology fee at the institution where enrolled; OR
- the annual tuition rate and technology fee charged to a PA resident at a state-owned university
- Annual Application Process: Log into www.pheaa.org

Challenges/Barriers

• While not required for EAP or MFEP, the 2024-25 Free Application for Federal Student Aid (FAFSA®) issues and delays are impacting some students' enrollment plans for fall 2024.



PA State Grant Program

- 2023-24 award year
 - \$5,750 max award
- 2024-25 award year
 - Due to issues with the 2024-25 Free Application for Federal Student Aid (FAFSA®), the PA State Grant application deadline for submission of the FAFSA has been extended to June 1.

Updates

- More than \$13 billion in grant awards since inception
 - Provided awards to more than 2.9 million students since 1966 program creation
- 2022-23 award year
 - Approx. 107,200 recipients
 - \$5,750 max / \$4,128 avg. award
 - Veterans qualify for max award

Challenges/Barriers

- 2024-25 FAFSA issues are impacting student enrollment plans for fall 2024
- Maintaining purchasing power of the awards as a percentage of tuition



PA Targeted Industry Program (PA-TIP)

- Prepares students with skills in high demand by today's employers
- Provides awards to students enrolled in short-term programs of study in the areas of Energy, Health, Manufacturing and Agriculture
- 2023-24 Commonwealth funding for PA-TIP held steady at \$8.652 million
- Program demand, particularly in health programs of study, is on course to exceed available 2023-24 resources

Updates

- 27,942 unique applicants
- 16,461 unique award recipients
- 90 schools with recipients
- \$64,741,025 in grants awarded
- 93% of graduates gained employment
- 78% of recipients graduated

Challenges/Barriers

Goals/Initiatives

- Improve outreach efforts to veteran staff within the Department of Corrections (DOC) through collaboration with external agencies
- Expand/enhance programming, workshops, and educational/employment opportunities within the veteran service units (VSUs)
- Increase the amount/availability of veteran-specific trainings and/or educational opportunities for employees/spouses/dependents
- Advocate for the creation/enhancement of veteran courts/tracks
- Expand veteran services within the DOC to field supervision to enhance the care continuum

JUDICIARY



Updates

- Mercer and Phoenix Veteran Service Units expected to expand in 2024; More than 100 beds will be made available via the expansion
- Muncy VSU Fundraiser in February raised \$3,985 for PA Wounded Warriors
- Houtzdale VSU opened its doors for two successful reentrant speakers
- PA DOC Veteran Services presented to the Board of Pardons on 4/11/24 to enhance their knowledge of VSU life for our veteran inmates
- Shining Light Reentry Academy's positive impact on the Dallas VSU
- DOC Veteran Services Team met with VBA Management Analyst Amanda Mills (Washington, DC) and her team on 4/22/24 to discuss C&P exam process

JUDICIARY



Challenges/Barriers

- Early identification for criminal-justice involved veterans
- Nursing home care for HTP veterans that have been parolled or are approaching their maximum date of sentence
- Housing for veterans with prior sex offenses
- Enhanced training for first responders dealing with veterans in crisis
- Additional programming for those incarcerated with PTSD and/or TBI
- Technological needs continue to create barriers for PA VETConnect delivery to incarcerated veterans
