General Schindler and Chairman Taylor presented Mr. Slep PASACDVA and Mr. Brian Natali DMVA-PIRO with the PA Commendation Medal for their outstanding and dedicated work with PA Veterans.

### **Chairman's Opening Remarks**

**Chairman Taylor** 

Chairman Taylor welcomed all the SVC members and DMVA staff to the meeting, and again congratulated Mr. Slep and Mr. Natali on receiving their awards from the magnificent work they did. The chairman welcomed the two new SVC members who had taken the oath of office to the commission. He also informed the members that Mr. Anthony Ficarri who had been listed on the agenda as a new member to be sworn in had fallen ill and was unable to attend the meeting. The chairman briefed the members on fellow member Mr. Charles "Chuck" Jackson suffering an injury to his knee and will be unable to attend. The chairman offered his thoughts and prayers for a speedy recovery to Mr. Ficarri and to Mr. Jackson.

The chairman said he was looking forward working with each SVC member and continuing his close collaborative relationship with the DMVA to build upon what the commission had started last year; and working closely with recently elected Vice-Chairman Mr. David Eisele.

The chairman informed the members he was very honored as the guest speaker at the Veterans Day ceremony held in the FIG National cemetery and expressed how well the FIG National Cemetery is maintained and the staff who worked so diligently to make it a wonderful event for our Veterans. He also mentioned his Catholic

War Veterans Post which held its 75<sup>th</sup> anniversary; and welcomed DAG-VA Weigl as a new Catholic War Veterans member.

The chairman introduced Mr. Matthew Hollenbeck TAL as the new VSO Grant Committee chairperson; and noted he intends to present past chairperson Mr. Bruce Foster with an award for his dedicated service later.

The chairman outlined how he would like to navigate the SVC in 2023: The chairman called on the members to prepare themselves to have input into how the SVC can move legislation forward and assist in creating new legislation to assist Veterans. The chairman would like the SVC to target certain Veteran centric issues; for example: suicides, women issues, and transportation to medical facilities for appointments. He informed members that beginning with the January meeting at least one of these target issues will be on the agenda for the members to discuss, evaluate and propose a course of action, such as new legislation or unblocking current legislation or proposing a new program while working in tandem with DMVA. As well as taking advantage of opportunities to present testimony to the incoming PA State Administration and House.

The chairman closed by saying how grateful and proud he is to be a member of the SVC, excited for what the new year can bring as a robust body working for PA Veterans. He thanked TAG, DAG-VA Weigl and Mr. Ferraro for their professional support to the SVC and him. He then invited everyone to enjoy lunch, a beverage of choice on his behalf and camaraderie after the meeting.

# **TAG's Opening Remarks**

**MG Schindler** 

TAG thanked the SVC members, their organizations and those who support those organizations for their commitment to Veterans. He expressed how grateful he is for their dedication and support and wished all a Happy Holiday and to enjoy their families.

TAG said November is a very busy month for Veterans breakfasts and events. Both he and DAG-VA Weigl attended as many as they could by splitting up. He noted that the PA Commonwealth employs a lot of Veterans and attended four recognition events honoring the dedication of Commonwealth Veteran employees serving our citizens. He also attended funding events for the Wounded Warriors Project to help insure its continued support to Veterans in need.

TAG briefed on his visit to the White House on Monday November 28, 2022, and his meeting with Mrs. Biden where he was able to discuss Veterans, and PA National Guard members concerns and needs. He said Mrs. Biden was very engaged. TAG informed members about the Lithuanian Military visiting FIG and a tour were provided to Lieutenant General Valdemaras Rupšys and staff. TAG also had a meeting with Chairman of the Joint Chiefs of Staff General Milley. They discussed the State Guard Partnerships and the PA National Guard.

TAG informed the members that he intended to visit each state Veteran homes during the holidays and directed the members to the homes holiday schedule. He also invited members and attendees to the Wreaths Across America event at FIG on December 17, 2022.

TAG informed the members there has not been any change in the number of PANG deployed overseas since February 2022. Deployment stands at 1003. He requested all attending to keep the soldiers/airmen and families in their thoughts and prayers.

# **Reading of Official and Other Communications**

**Chairman Taylor** 

The chairman noted he had one official communication in the form of an email. It was based on the question from Mr. Johnson DAV asked to VISN 4 at the October 7, 2022, SVC meeting. The chairman stated he wasn't satisfied with the response from VISN 4 and would like the SVC to take the lead on the presumptive diseases question even on a national level if so required.

# Below is Mr. Johnson's Question, VISN 4 response and Mr. Hudzinski's comment.

"Mr. Johnson, DAV: We spoke earlier, and I mentioned the presumptive diseases from Vietnam, Gulf War, 9/11. And on 9/11, it has melanoma as a presumptive. Vietnam Veterans are also suffering from that disease. It's been deadly to us. If you can investigate that for us, why that's not on there? Thank you.

Mr. Liezert, VISN-4: Thank you. I'll take that back and try to find out more."

### VISN 4 response

**Answer:** PACT Act allows VA to improve the decision-making process for determining what medical conditions will be considered for presumptive status. This will allow us to make more timely decisions regarding disabilities.

If a Veteran has a cancer or illness that's not on our list of presumptive conditions, but he/she believes it was caused by Agent Orange exposure, the Veteran can still file a claim for VA disability benefits. Veterans are encouraged to file a claim for any condition that they believe is linked to serving in the military, whether from an injury or illness that was incurred in service or a disability that didn't appear until after service. If the illness was not diagnosed in service, a medical link between the disability and conditions of service is also needed.

# What evidence will I need to submit with my claim?

### You'll need to submit these records:

- A medical record that shows you have an Agent Orange-related health condition, and
- Military records to show how you were exposed to Agent Orange during your service

# If your condition isn't on the list of presumptive conditions, you'll also need to provide at least one of these types of evidence:

- Evidence that shows the problem started during—or got worse because of—your military service, or
- Scientific or medical evidence stating that the condition you have is caused by Agent Orange. Scientific proof may include an article from a medical journal or a published research study.

### Mr. Hudzinski's comment

Mr. Hudzinski: "This is not directly answer Leonard's query in my opinion. We all should know by now to apply for a condition we believe relates to military service. This response is entering upon the nuts and bolts on

how to do that.

What Len asked is why a condition so prevalent among Vietnam era Veterans does not have presumptive status; why the Congress could not find its way on this matter officially, since they have acknowledged it for some succeeding generations. Specifically, because of the PACT Act, it is a post-9/11 and Gulf War presumptive condition related to Burn Pit exposures.

Therefore, the response calls for follow-up. In fairness to Mr. Liezert, this is a question beyond him to answer as he is a public official in the "works section" of the VA, specifically healthcare operations, and this matter is also related to the VBA side of the house and at national policy levels even then. He seems not to have relayed the question upstairs (?) or the question was not voiced correctly.

Indeed the matter rises to Washington levels, because the VA and working in conjunction with the NASEM (although one may doubt this in the future based on the current Secretaries actions on another matter: birth defects among Veterans' children related to exposures) provides guidance to the Congress. In fact, the Congress could be queried at this time as one must suspect the issue was probably raised in the queer deliberations on the "All-Sorts" PACT Act.

Consequently, I suggest you use your Executive Secretary to have OVA answer this question after inquiry. May be an issue which requires diligence on behalf of our Veterans by this state and other states if there is no proper answer. Who knows at this point?"

### **Deputy Adjutant General-VA Remarks**

BG (PA) Weigl

DAG-VA greeted the commissioners and wished them a very Happy Holiday. She encouraged the commissioners to view the BVH Holiday schedule because there are many events taking place, and the Veterans would enjoy their participation. She said the holiday events will span from December 12 to 21, 2022, and encouraged commissioners to participate; as well as with Wreaths Across America on December 17.2022. DAG-VA then demurred to BVH Director Mr. Travis Davis and reserved further comment until after the brief.

### **DMVA Bureau of Veterans Homes**

Mr. Travis Davis

Mr. Davis informed the commissioners that BVH had many Veterans Day celebrations throughout the BVH structures which were very successful and participation centric. He thanked all those that participated, and their organizations helping to make the event so successful.

Mr. Davis briefed on the COVID-19 situation: there was a slight increase in cases at Gino Merli and the Erie Soldiers and Sailors Home but should be back in the green shortly. The other homes were in a COVD-19 stabilization status. He said there were 18 staff members that had tested positive for COVID-19 BVH wide since his last update to the commission.

Mr. Davis reported that currently BVH's patient capacity stands at 955 which is a 64% occupancy rate. He noted this is down a little due to COVID-19 having a direct impact on their abilities to bring Veterans into the homes. He said there are approximately 370 Veterans awaiting admissions.

Mr. Davis reported on the Medicare/Medicaid rating of BVH: the Delaware Veterans Center and Eire Soldiers and Sailors Home were given a 5-star rating. Gino Merli, Southeastern Veterans Center, and the Southwestern Veterans Center received a 4-star rating; and the Hollidaysburg Veterans Home received a 3-star rating. Mr. Davis further informed the commissioners that three of BVH's homes were listed by Newsweek magazine as being in the top 25 homes in the PA, and News and World Report magazine listed Hollidaysburg Home as one of the best.

Mr. Davis said the construction at the Erie Soldiers and Sailors Home is more than 90% completed on the campus and the expectations are to have approval for opening the renovated areas by December 6, 2022. The

construction at the Hollidaysburg Home is on continuing and on track. He noted the survey in the Delaware Veterans Center will be completed by mid-December regarding skilled nursing.90

Mr. Davis briefed commission on a new hiring initiative: Walk-In Wednesdays. The initiative was designed to assist with helping to address the hiring shortage by streamlining the process. The candidates can come into the homes, file an application, take a tour, and have an interview all in the same day. Mr. Davis reported the Walk-In Wednesday program received some good media coverage by a local TV news company- FOX news.

DAG-VA Weigl requested that the commissioners share the Walk-In Wednesdays with their service organizations. She explained that BVH is short-staffed nurses and CNAs which is having an impact on BVH's ability to fill beds which is a high priority. She said the Veterans awaiting admissions are spending a lot of money until they can be admitted to one of our homes.

# Questions/Discussion

Mr. Hudzinski: What type of advertising are you conducting?

DAG-VA: All available media outlets that DMVA uses, all social media platforms including local media.

Mr. Hudzinski: Do you have a budget to advertise in the local newspapers?

DAG-VA: Yes, we had a budget last year and we'll do the same thing this year.

Mr. Getz: If you give us (VFW) the information we will push it out to all our posts.

DAG-VA: You'll have it before the end of today.

DMVA PIRO Mr. Brian Natali

Mr. Natali reported that the read ahead contained a lot of information regarding the operations of DMVA-PIRO. Mr. Natali then called for a vote to approve the report. Chairman called for a motion. (See below)

He reported to the commissioners the number of legislative requests directed to improve the lives of our Veterans. The hiring of more RPOCs to address the needs of our Veterans, improving the VETConnect website and improving the claims processes all to deliver better services.

Mr. Natali briefed the commissioners on Title 51 consolidated statues section 8904 requiring an adjustment to the RETX presumptive amount every two years based on the inflation rate as reported in the consumer price index. The presumptive amount is calculated on the inflation rate per consumer price index which was 13.4%; therefore, the presumptive amount would move from \$95,279.00 to \$108.046.00 beginning on January 1, 2023, if SVC approves. Chairman called for a motion. (See below).

### **Approval of State Veterans' Programs Reports**

**Motion:** Mr. Bernard MacDonald, AMVETS, made a motion to approve the programs report.

**Second:** Mr. David Eisele, PASACDVA, seconded the motion.

The body agreed; motion carried. Programs reports approved.

### **Approval of RETX Presumptive Amount**

**Motion:** Mr. David Brady, MCL, made a motion to approve raising the presumptive amount per law.

**Second:** Ms. Terri Lynn, DAV, seconded the motion

The body agreed, motion carried. New Presumption Amount increased to \$108,046.00 starting 01JAN23

### **Briefing: 43 PA Code, Chapter 5 Amendments Changes**

Mr. Jeffrey King

Mr. King informed the commission the Regulatory Review Action Plan which produced the proposed amendments was the cumulation of two years of work consisting of a 25-person working group formed from SVC members and DMVA staff.

Mr. King briefed on the following: Title 43 PA Code Chapter 5 is proposed to be retitled from "Bureau for Veterans' Affairs" (which no longer exists) to "State Veterans' Programs to provide consistency with Chapter 7, "State Veterans' Home." Chapter 5 was last reviewed/amended in 1991, some 31 years ago. The statutory amendments have changed the organization of the department and important aspects of several of our programs over that time. The various interpretations and adjudication guidance have been issued in policy over that time which are now best addressed in regulation. We also find it advisable to structure the rules consistently: definitions, application, adjudication, appeal, and administration.

In subchapter A, Veterans' Temporary Assistance when the Veterans' Emergency Assistance program was ended and turned into the Veterans' Temporary Assistance program in 2016, the regulations were never updated. Our proposed amendments codify the "VTA Guidelines" that we have been using since 2016, bringing the regulations current and in line with statute. We should offer more detailed adjudication procedures, particularly with respect to determinations of need. We should extend the reconsideration period from 10 to 30 days and discuss the role of the VTA Fund Committee at DMVA.

In subchapter B, Educational Gratuity we need to address dual application and payment for students attending two or more educational institutions, as well as application procedures for students transferring between educational institutions. We should describe approved educational institutions and proposed rules on full-time attendance. Create reasonable annual expense allowances in the financial need assessment for students residing off-campus and clarify Chapter 35 benefits are not precondition to EG but are counted in the financial need assessment.

In subchapter C, Disabled Veterans' Real Estate Tax Exemption we should redefine "income" in the financial need assessment, limiting it to reportable income and specifically exempting Veterans' benefits. Explain eligibility based on "blind," "paraplegic," and "loss of two or more limbs." Ties these definitions more closely to those applied in Blind and Amputee & Paralyzed Pensions programs. Create a rationale behind the cost-of-living allowance, tying it to amounts in the federal Maximum Thrifty Food Plan and Consumer Expenditure Survey; adjusted for inflation every two years. Provide a comprehensive list of acceptable expenses to eliminate ambiguity in the income/expense assessment. Add a definition of qualifying dependent tied to IRS rules. Return adjudication of eligibility back to the county, consistent with state law, along with clear guidance. (Assessment of financial need remains with DMVA, consistent with state law.) Appeal procedures more clearly address eligibility issues and issues concerning administration of the exemption that are properly appealed to the county boards of revision of taxes or assessment appeals.

In subchapter D-E, Blind and Amputee & Paralyzed Veterans' Pensions allow for application by spouse, legal guardian, or person exercising general power of attorney on behalf of a Veteran unable to apply due to medical condition. Add clarity to the list of required supporting documentation and hold DMVA to a 30-day adjudication timeframe after receipt of a fully developed application. Clarify that pensions are not retroactive to effective date of VA disability ratings; they are effective on date of application to DMVA. Require timely notification of changes (i.e., a move or death) and provide procedure on reimbursement of debts.

Lastly, the Military Family Relief Assistance Programs Guidelines: The authorizing statute for MFRAP specifically disallows formal rulemaking in favor of the publication of guidelines. These proposed amendments may be published as a simple notice (without the full formal rulemaking process) in the *Pennsylvania Bulletin*. There is a two-level approval process for MFRAP grants. The MFRAP VSS in the Programs office has authority to approve grants up to \$1,500.00. An MFRAP Committee within DMVA can approve grants up to

\$3,500.00. The work group proposed adjusting the VSS's authority up to \$1,600.00 to align with VTA approval authority.

### Questions/Discussion

Mr. Hudzinski: Why don't we just use the same definitions in the need assessment that the VA applies for its pensions?

Mr. King: The need assessment for the RETX program is a straight income-expense assessment. So the only thing we take into account are annual income and allowable expenses tied to the household. The VA applies a full resource assessment, basically an assessment of the entire estate for the Veterans' and Survivors' Pensions. It's a very different assessment.

Mr. Brooker: Asked about the VA pension excluding war time service and would ask DMVA so the same.

Also, thought a look back over financials like the VA does would be a good idea.

Mr. King: Good recommendation and working with counties on doing that with a look back.

Ms. Pettis: Said it was the opinion of the Office of Chief Counsel that only those Veterans that are 100% permanent and total disabled are entitled to RETX.

Chairman Taylor called for a motion to adopt the proposals and recommendations. (see below)

Good Morning Everyone

You have our VISN 4 updates and slides in your read ahead material. I just wanted to highlight a couple topics and provide some additional information on the upcoming PACT Act Awareness events and Outreach opportunities.

**Medical Center Leadership Update:** I want to provide a Medical Center leadership update:

Ken Mortimer, Associate Director at the VA Medical Center in Huntington, West Virginia continues to be detailed to the Altoona Director position as we recruit for a new leader for Altoona.

Derek Coughenour, Associate Director at the Altoona VA continues to be detailed to the position of Acting Associate Director at the Philadelphia, VAMC. and

Carl Parrish, Chief Financial Officer at the Altoona VA is currently detailed to the position of Acting Associate Director at Altoona.

Robert Kling, the CFO at the VA Pittsburgh continues to serve as their acting Associate Director.

**PACT Act Awareness Events:** I wanted to provide an update on the upcoming PACT Act Awareness events.

VA will be hosting over 90 PACT Act awareness events the week of December 10-17, 2022. Each in person event will be hosted by a local VA Medical Center and will be open to the media and livestreamed if possible.

Veterans, Veterans families, caregivers, survivors and advocates will be encouraged to participate. The local media and Congressional offices will also be invited to attend.

In VISN 4 we are hosting 3 events: In Pennsylvania, **Pittsburgh VA Medical Center** is hosting a PACT Act awareness week event on Wednesday, December 14 at 2 p.m. that will include a speaking engagement and enrollment opportunities. They will have a separate VBA claims clinic on Friday, December 16.

**Our Philadelphia** VA Medical Center will also be hosting an event for the Eastern site of our State on Monday, December 12 from Noon-1pm that will include a speaking engagement and Eligibility & Enrollment opportunities.

In Delaware, **Wilmington** will be hosting their event on Friday, December 16 from 11:30a-2:00p at the local National Guard/Reserve Conference center. Their event will include a speaking engagement, Health Care Eligibility and Enrollment; Benefits & Claims Assistance; Toxic Exposure Screening, Vaccination Clinic; and Patient Advocate Assistance.

### **DMVA**

I also wanted everyone to have awareness I have been working with Richard Hamp to look for ways VISN 4 can continue to partner with the DMVA to encourage enrollment in VA Healthcare and raise awareness of both federal and PA state benefits. Specifically, VISN 4 wants to help promote PA Vet Connect as well as other benefits PA Veterans may be eligible for at the State level.

Joel Mutschler is scheduled to give a capability briefing on the PA VETConnect program at our next VISN 4 Outreach committee meeting the first week of January. Joel will also be incorporating a State Benefits briefing. We look forward to this continued collaboration with the State to enhance our Outreach to Pennsylvania Veterans.

That concludes my update. Please let me know if anyone has any questions.

### **Legislative Committee**

Mr. Richard Hudzinski

Mr. Hudzinski reported the following:

### A New Approach to Establishing Legislative Goals

The chairman has been meeting with members through emails and zoom. A tentative list of goals based upon Pa War Veterans Council input primarily was produced. But the meetings and discussion have also led us to formulate

a different approach towards developing goals to propose to the Commissioners -- all to improve our functioning and the commission as a whole. Let me explain. ... I will quickly review what was written to the Chairman:

### What

- 1. Our commissioners need to be integrally involved in the development of goals which they themselves believe, if accomplished, will truly benefit the Veterans of the Commonwealth. Therefore, the Commissioners need to be canvassed to determine their current views of what the SVC's goals should be. Indeed, they may raise issues needing addressing that the committee process would not.
- 2. Goals must have objectives to accomplish them. Those objectives must be measurable and recorded. While principally the responsibility of a committee to develop, the commissioners need to review them and ensure they are comprehensive enough; and that any goal to be adopted will ultimately have objectives.

How

What then would this require process-wise?

- 1. Use of committees to get the ball rolling. As part of the canvassing process, committee chairs would be requested to present the goals of their committees which they think should be adopted and the objectives they deem necessary to accomplish them.
- 2. Obtaining formal commitment from the commissioners. We must acknowledge that most commissioners, per statute, come to the table representing an organization, *de facto*. That implies, when they vote aye, that they are committing themselves and their organization to doing work to achieve an adopted goal. We need them to engage their organizations for us to be more effective. Because some commissioners apparently need formal support from their organizations before making any decision on a goal, adopting a goal will not always be a quick process.
- 3. **Reviewing the goals of the PWVC.** The Legislative Committee, as would the other committee chairs, will routinely examine the PWVC's issues and goals for the current year, because of its statewide reach, to determine their applicability for the SVC consideration. While we think both organizations can have the same goal pertaining to an issue, but our objectives may and should in some cases be very different from the objectives of the PWVC. Remember that we are working within the administration. The PWVC has no such constraint.



### **New 2023-2024 Co-Sponsorship Memos**

(HCO = House Co-Sponsorship Memo) (SCO = Senate Co-Sponsorship Memo)

HCO 15 (Harkins, Patrick) - Expands the lost of free hunting licenses available to disabled veterans to include antlerless deer, bear archery, muzzle loader, migratory game bird, elk and special wild turkey licenses.

HC0 29 (Ciresi, Joseph) - Considers exempting injured and decorated veterans from vehicle registration fees.

HCO 52 (Staats, Craig) - Requires licensed funeral directors, funeral entities, or cemetery companies to notify the county veteran affairs director of a deceased serviceperson having legal residence in the county so they can assist the family.

HCO 55 (Tomlinson) - Establishes the Family Care Act, a statewide Family and Medical Leave Insurance Program, which requires up to 2 weeks of paid sick leave if an eligible employee is quarantined or experiencing Covid-19 symptoms.

HCO 109 (Evans, Carol) - Establishes a recent veteran property tax and rent rebate program.

HC0 124 (Nielson, Ed) - Creates a specific license exemption for participants in organized therapeutic fishing activities.

HCO 136 (Sappey, Christina) - Constitutional amendment extending full property tax exemption to disabled veterans regardless of wartime service.

HCO 182 (Evans, Carol) - Provides DMVA and PA Housing Agency shall collaborate to provide assistance to veterans who are homeless or are at imminent risk of becoming homeless.

HCO 196 (McNiell, Jeanne) - Reduces residency requirements for veterans and their families applying for the state educational gratuity program to one year.

HCO 221 (Ciresi, Joseph) - Requires all public schools to mark Veterans Day as a school holiday to continue to show respect for veterans.

HCO 245 (Deasy, Daniel) - Amends Title 51 (Military Affairs) to require the establishment of a Combat to College Program.

# New 2023-2024 Co-Sponsorship Memos

HCO 254 (Deasy, Daniel) - Provides for limits to fees cemeteries can charge for markers commemorating deceased veterans.

HCO 357 (Kenyatta, Malcolm) - Provides emergency relief to those who previously received support through the General Assistance program.

SCO 19 (Brewster, Jim) - Exempts the cost of fishing licenses for veterans and other individuals taking steps toward physical or mental recovery as part of therapeutic recreation events or programs.

SCO 124 (Mastriano, Doug) - Exempts disabled veterans benefit payment from income calculations of any commonwealth program or benefit.

SCO 161 (Fontana, Wayne) - Implements a Green Alert system to warn the public if an at-risk veteran is missing.

SCO 201 (Mastriano, Doug) - Allows the Pennsylvania Squadron of the Navy Club to the United States full membership on the State Veterans Commission.

SCO 238 (Mastriano, Doug) - Created a loan guarantee program in support of veteran owned businesses. Loans would be limited to \$250,000 for any one loan.

SCO 274 (Mastriano, Doug) - Establishes the Veterans Home Advisory Board within the Office of Deputy Adjutant General for Veterans Affairs

SCO 307 (Brooks, Michelle) - Provides that VFWs and American Legions are tax exempt.

# **Bureau Activities**



- We serve over 700,000 veterans and approximately 18,000 members of the Pennsylvania National Guard. We are here for them, their families, and the nearly 2,500 active and over 10,000 reserve component military members and families that call PA home. We are a community of over 2 million Pennsylvanians strong.
- **Top issues facing our veterans' community** across the commonwealth are Homelessness, Transportation, Employment, Mental Wellness, and veterans benefit awareness.
- Since **PA VETConnect** launched, we have made more than 16,500 connections with federal, state, and local government officials, non-profit organizations, and community leaders to build relationships and enhance our network capabilities with over 1,900 resources.
- **PACT Act** Veterans can visit www.va.gov/PACT to get the latest information and updates or connect with a Veteran Service Officer for assistance. Since the PACT was enacted, the federal VA has seen an increase of over **175,000 claims nationwide**.
- Veterans Trust Fund (VTF)- Since the grant program began in 2013, a total of \$6,700,590 has been awarded to organizations that serve PA veterans to include \$1.4 million last year. 2023-24 Applications are due 19 Jan 23. - **Title 43 Regulatory Update Project** We conducted a regulatory review of the application and adjudication procedures for our state veterans' benefits programs codified in 43 Pa. Code. The review follows a detailed process governed by the Regulatory Review Act and overseen by the Independent Regulatory Review Commission. Members from the SVC have been included on the associated working groups. An Exposure Draft was provided to key stakeholders, and we will close the informal comment period on 19 Jan 23.
- **Governor's Advisory Council on Veterans Services** met on November 2, 2022. The Governor attended for a year-end review. 

# AMPUTEE & PARALYZED VETERANS' PENSION





# **BLIND VETERANS' PENSION**







# Improvements to the Access to Care website

Average wait times for all VHA medical centers and clinics are now calculated to include additional steps in the appointment process that had not been captured in the past.

- For <u>new patient</u> appointments, average wait time is calculated from the earliest time a
  request for care is consistently recorded in the scheduling system to the date the
  appointment is completed or the date it is scheduled to occur if not yet completed.
- For <u>established patient</u> appointments, average wait times are measured from the date agreed upon between a Veteran and provider for future care and ends on the date care is received, or the date that care is scheduled to occur if it has not yet occurred.

The upgraded calculation makes the website more reflective of the complete process of requesting and receiving care. Averages are representative of general performance and may not represent individual experience. Average wait times are never used to determine eligibility for community care.

# **Leadership Update**

### **PACT Act Awareness Events**

VA medical centers across the country hosted more than 90 PACT Act awareness events during the week of December 10-17. Every state was required to have at least one inperson event and provide a livestream if possible.

Veterans and their families, caregivers, survivors, and advocates were encouraged to participate. Congressional staffers, VSOs, community partners, and local media were also invited to attend.

In VISN 4 we hosted 3 events in Philadelphia, Pittsburgh and Wilmington, Delaware. All three PACT Act awareness events were well attended by Veterans and viewed by several hundred virtually. We were honored to have both the President of the United States and Secretary of Veterans Affairs attend in person and speak at our event hosted by the Wilmington VA.

# **Patient Experience Update**

Nationally, VA's trust score over the last 90 days was just over 90%. In VISN 4, our trust score was 93% which is the second highest VISN in the nation. 73.5% of the comments in VISN 4 were compliments, higher than any other VISN. The top compliment themes were quality of care, cleanliness of facility, satisfaction with specialty care, interactions with staff, and quality of care from student and resident staff.

# **Caregiver Support Update**

Resources for Caregivers

VA's Caregiver Support Program (CSP) celebrated National Family Caregivers Month in November. Each facility across VISN 4 hosted events for caregivers including trainings on problem solving and self-care, 'grab and go' resource fairs at several facilities and CBOCS, tea and cookie event, laughter therapy event, as well as appreciation gifts, activity packets, and thank you cards.

# Program of Comprehensive Assistance for Family Caregiver (PCAFC)

- VA is reviewing and examining the current Program of Comprehensive Assistance for Family Caregivers (PCAFC), including a thorough review of the eligibility criteria, and improving the overall Veteran and caregiver experience.
- VA announced it is extending the amount of time that Legacy Participants, Legacy Applicants, and their Family Caregivers within the PCAFC will remain eligible for the program. This will include all services, supports and benefits until September 30, 2025.
- VA has suspended annual reassessments during a review of current eligibility criteria for all those enrolled in the Program of Comprehensive Assistance for Family Caregivers (PCAFC). VA will continue to initiate reassessments for Veterans and family caregivers who request to be considered for an increase in stipend level or if there is evidence of an increased need for personal care services. During this time, VA will not remove anyone from the program or decrease any support based on the annual reassessments.
- As part of the VA MISSION Act, Phase II of program expansion occurred October 2022, expanding the program to include family caregivers of eligible Veterans from all eras who were seriously injured in the line of duty.
- New applications continue to be received. These are processed in a timely manner.
- In addition to the VHA Clinical Review Process, there are additional appeal options for Veterans and caregivers. The Caregiver Support Line (CSL) (1-855-260-3274) can assist Veterans and caregivers with navigating these additional options and with providing information about filing a review or appeal.

# Program of General Caregiver Support Services (PGCSS)

- Facilities are continuing to develop, implement, and enhance services and education for caregivers.
- Caregiver Support Program staff, VA providers and professionals have received training in the Campaign for Inclusive Care, which engages caregivers as part of the Veteran's care team.
- Family caregivers of Veterans who aren't eligible for PCAFC can still receive support and resources through PGCSS.

# My VA Images

Patients can now use the My VA Images app to share photos and videos with their providers to assist with their care. My VA Images allows providers to request photos and videos directly from their patients. The app will guide patients through taking the required photos and/or videos and remind them when the images are due.

My VA Images is a secure web-application that protects patient information from upload through submission. The application can be used when providers want to see a picture of a new rash or want to evaluate the use of equipment sent to a home to support rehabilitation. Patients can use a smartphone or personal computer to avoid travel and wait times while receiving expert health care from anywhere, anytime. Patients should talk to their VA care team if they are interested in using this application.

# Secure Messaging

Secure Messaging through My HealtheVet provides Veterans access to care by allowing them to securely exchange messages online with members of their VA care teams. Veterans can send messages to:

- Ask non-urgent, non-emergent health questions
- Update their VA care team on their health and wellness
- Schedule, reschedule, or cancel VA appointments
- Ask routine administrative questions
- Request VA medication renewals or ask a question about their VA medication

To access Secure Messaging, Veterans should sign into their My HealtheVet Premium Account and select Messages from the homepage. Their VA care team should respond to messages within three business days (Monday-Friday, not including Federal holidays).
