

### **Mission/Vision:**

Expand awareness of and access to services, supports, benefits, and opportunities for Pennsylvania's aging veterans and their families and caregivers so that they may live and thrive in their communities.

## Goals:

- 1) Increase awareness of services and supports for aging veterans and their families and caregivers among professionals within PA's Aging and Veteran Services networks.
- 2) Increase awareness of opportunities for community engagement among aging veterans, their families and caregivers, and those serving them.
- 3) Safeguard Pennsylvania's aging veterans from abuse, neglect, exploitation, and self-harm.



**Goal 1:** Increase awareness of services and supports for aging veterans and their families and caregivers among professionals within PA's Aging and Veteran Services networks.

"Expanding Long-Term Care Services to Pennsylvania Veterans"

Consider using public and nonpublic nursing facility bed capacity for Veterans in need of long-term care if the DMVA beds are unavailable and Improve Veterans' access to existing Home and Community Based services and programs through education and navigation services"

**How?** collaborating with PPL office to gather information on how to make this change happen

Who? Margo and Jonathan, PPL staff

**What?** information gathering with focus on how to improve reporting and policy change for use of public and non-public nursing facilities

**When?** *March* 9<sup>th</sup>, 2021

**Outcome:** The role of the aging committee would be better served by generating an awareness campaign providing communications to local nursing homes on how to identify veterans and getting them assessed or reassessed through the federal VA so they could access benefits through that route.

**Goal 3:** Safeguard Pennsylvania's aging veterans from abuse, neglect, exploitation, and self-harm.

"Expanding Long Term Care Services to Pennsylvania Veterans"

Identify barriers in Long Term Care when reporting potential financial exploitation and Collaborate with agency stakeholders to identify areas for judiciary or policy change to improve reporting and outcomes

How? Partner with financial exploitation study to glean information on recommendations and policy changes

Who?, Margo and Jonathan in conjunction with PDA and the IDT task force state agencies

**What**? *Interagency collaboration to prevent financial exploitation* 

When? Monthly through April

Outcome: Aging committee was able to provide 2 recommendations to the FETF and the FETF has adopted those changes as part of their Task Force Strategy

- 1. Create a feedback loop between law enforcement and long-term care facility staff to help identify possibly missed opportunities/evidence during an investigation. It may help improve investigations in long-term care facilities to have the assistance of a trained detective to identify any areas missed during the investigation.
- 2. If a Report of Need is made from an agency, rather than a private party, the outcome of the investigation should be shared between agencies.

**Next steps**: Reaching out to local law enforcement agencies and BVH staff to invite to a handful of meeting to discuss best practices, challenges, and opportunities when reporting possible financial exploitation. Hoping to host 5 meetings and be ready for reporting in September when the full FETF being led by Sec. Torres reconvenes.

using social media platforms.

- Initiate the veteran pension poaching postcard effort

### **Recommendation 4**

Host regional or local town halls or listening forums for aging veterans, their families and caregivers to attend – time to learn about resources, voice concerns, identify service gaps, brainstorm innovative solutions

### Vision:

Be the premier forum for seamless communication and collaboration in effectively understanding and responding to veteran homelessness within Pennsylvania.

### Mission:

Build collaborative intergovernmental and community-based relationships to identify and promote awareness of the resources that could help veterans experiencing or at risk of housing instability.



**Recommendation 1:** Consider action on issues deemed most pressing by stakeholders: lack of warming shelters, lack of emergency shelter beds, lack of affordable housing, impacts of COVID-19

**Recommendation 2:** Advocate for Coordinated Entry Access Sites to more VA Medical Centers and SSVF providers

**Recommendation 3:** Seek to uncover more resources for National Guard or Reservists who do not qualify for SSVF or traditional veteran homeless programs and advocate for a streamlined and standard referral flow for these individuals

Recommendation 4: Have PA VETConnect RPOCs routinely engage in CoC scrub calls and homeless veteran list reviews

**Recommendation 5 – workgroup established; recurring meetings being held; Erica Moore lead:** Collaborate with Women Veterans committee to seek more solutions for women veterans (and those with children) experiencing trauma which could lead to homelessness

**Recommendation 6 – discussions underway:** Partner with Aging Committee to discuss potential solutions for aging veterans who experience housing instability and discuss ways to promote better communication with long-term care industry

**Recommendation 7 – workgroup established; recurring meetings being held; Jen Spitler lead:** Partner with Judiciary Committee to discuss potential solutions for hard-to-place veterans exiting incarceration who have been historically hard-to-place

**Recommendation 8:** Obtain data from all CoCs, all SSVFs and all VA Medical Centers on a quarterly basis to better understand veteran homelessness across PA

**Recommendation 9 – completed:** Provide DCED, PHFA and PHAs with insight on veteran advocates who can speak to the need for veteran-specific housing and help developers plan wisely regarding location and tenancy plans for new or revitalized housing



### **New Committee Recommendation:**

Promotion of VA's Project CHALENG (Community Housing Assessment, Local Education, and Networking Groups)

- Raise awareness of and promote participation in the annual VA CHALENG survey
- Work with VISNs 4, 2 and 5 to obtain survey results pertinent to PA counties and analyze reports for unmet needs and resource gaps
- Assist VAMCs with their CHALENG meetings
- Legal assistance was an unmet need noted in 2020 CHALENG survey outcomes 50% of top 10 unmet needs for both male and female veterans were for legal assistance of some sort
  - Question for Judiciary Committee are there members who are willing to discuss a plan to address these needs in PA?

- Complete a survey for each VA catchment you provide service within or have insight for.
- Veterans who are or have experienced homelessness and those with insight into the needs of homeless veteran households including VA staff, state and local government, community providers, and interested community members should participate.
- **2021 CHALENG meetings**: VAMCs are still determining whether they can host in-person meetings or virtual meetings this year, or if they will only be able to promote the survey.

### **VA Homeless Programs:**

- VAMCs can now accept HUD-VASH referrals under the new expanded criteria (1 day active-duty service, no dishonorable, no court martial). This is the same criteria for SSVF and GPD.
- If receiving VA homeless services under expanded criteria noted above, veteran could have access to a free Samsung phone with a one-year data plan. Contact VAMC about eligibility and availability.
- VA just established a national contract with rideshare programs to help **those enrolled with** VA homeless services under the expanded criteria noted above get to appointments (medical, housing, SSVF office). Brand new and more to come!



### **Supportive Services for Veterans Families (SSVF):**

- Awards for FFY 2022 have been announced.
- SSVF information paper and coverage map have been updated.
- 12 grantees remain the same since FFY 2019.
- All 12 grantees saw increases in their awards.
- A total of \$16,189,386 was awarded to our 12 SSVF grantees for FFY 2022.
  - This is an increase of nearly \$2 million from FFY 2021 but is still less then the overall amount received by PA grantees in FFY 2017 and FFY 2018.
  - Please note that VMC-Philadelphia serves 5 counties in PA as well as 10 counties between NJ and DE. Their award is for their entire coverage area, not only PA counties. They estimate that their FFY 2022spending in PA will be about \$3.5mil of their nearly \$5.5mil award.

- VMC-Central PA is now serving as a veterans' coordinated entry access site for the 33 counties in the Eastern PA CoC. Veterans can call there directly at 1-844-226-0368, ext. 206.
- VLP is also serving as a veterans' coordinated entry access site, but only for Bedford, Blair, Cambria, Centre, Fulton, Huntingdon and Somerset Co.
- All 12 SSVF grantees were prepped to provide data ahead of Nov. GAC-VS meeting.
- SSVF is about more than just housing veterans. It is about connecting them to the resources they need to address the issues that led to, or resulted from, homelessness. In many cases, SSVF literally saves lives!
  - VOA: Vet on street with life-threatening physical health issues. Brought into bridge housing and team persuaded vet to go to hospital. Will move into housing on 1 Sept.
  - YWCA: Vet in PSH with substance use disorder which hit crisis point recently. Opioid response team encouraged him to seek treatment which he stated saved his life.
  - VLP: Vet in a shelter was asked to leave when his previous incarceration was discovered. He was connected to housing where he developed a deep friendship with another veteran in the building. Now they are roommates with the supports they need to thrive.



### **Miscellaneous updates:**

- Committee will continue spotlight presentations at monthly meetings to highlight various programs that can support veteran households and homeless providers.
  - Spotlights are considered a value-add by members.
  - Open invitation to other Committees' members or Council members.
- CDC Eviction Moratorium ended 7/31/21.

# Registered Apprenticeship

### **Concept**

- It is an employer-driven, "learn-while-you-earn" structured training model specific to an occupation
- Combines on-the-job learning with job-related technical instruction.
- An apprentice is a full-time, paid employee from the start of the program
- Upon completion, apprentices receive a national portable credential from Pennsylvania (JOURNEY WORKER CERTIFICATE).

### **State Participation**

- Veterans can access local, State, and Federal Workforce Development funds to provide support for apprenticeship, including wage reimbursements to employers or wrap around services for apprentices: WIOA Funds, Pell Grant
- **GI Bill:** tax-free monthly stipend in addition to the wages they receive as an apprentice. Veterans also receive tuition and fee payments for classroom instruction.
- Apprenticeship State Expansion (ASE) Initiative: \$1,500 per apprentice to support the classroom or on-the-job training of apprentices from underserved populations: including women, people of color, veterans and young adults (ages 16-24).
- As part of the PAsmart initiative, funds are available to support program infrastructure building and concentrate on initiatives serving underserved populations like veterans
- DCED, L&I, Dept. of Ed., OVR, DHS, Dept. of AG, and Corrections are all involved in apprenticeship initiatives, often with a statewide reach



# Registered Apprenticeship

### PA Key Data/Trends

- 877 unduplicated program sponsors: organizations, that operate in some cases multiple programs and assume the responsibility for administration and operation of such programs
- 1,584 Registered Apprenticeship Programs across the Commonwealth and 72 registered Pre-apprenticeship programs
- 17,504 registered apprentices currently active.
- 8.5% of the currently active apprentices identified as veterans
- Since the ATO's inception in 2016, Apprenticeships in the Education sector have grown by 83%, the Healthcare sector by 71%, and in Technology by 64%
- Published data that highlighted Pennsylvania's lead in the six-state region (PA, WV, VA, DE, MD, DC) in total number of programs, apprentices, and completions.

### **Key Changes/Initiatives**

- Updated the PA apprenticeship and pre-apprenticeship standards acceptance and registration process
- Updating our Labor and Industry and PA CareerLink web pages
- Creating PA specific knowledge products
- In the future: offering workshops and training for workforce development staff, as we want these individuals to know the who, what, when, where, why, to connect their jobseeker or employer clients to apprenticeship.



## Troops to Teachers

### **Concept**

- Assist transitioning service members with meeting the requirements necessary to obtain teaching certification.
- Provide individualized counseling to assist program participants in exploring and selecting the best pathway to teaching based on unique needs, goals and skills
- Address teacher shortage areas in the K-12 schools that service low-income families in critical shortage areas

### **State Participation**

- Provide grant oversight to assure deliverables are met
- Provide leadership within the Department of Education to assure cooperation and support for the program
- Address barriers that prevent veterans from meeting teacher certification requirements

#### PA Key Data/Trends

- Over 7,000 veterans have received specific and targeted information related to the program
- To date, 75 program participants have been hired
- Since the PA TTT grant pilot program, 148 individuals have completed the requirements to become a TTT participant. 100% of these individuals have received one-one counseling through personal e-mails or phone calls
- Over 1,000 veterans have been provided information regarding certification via phone calls, e-mails, up meetings

### **Key Changes/Initiatives**

- Due to the re-alignment of funding within the United States Department of Defense, the Troops to Teachers program will be sunsetted on October 1, 2021.
- The Pennsylvania Department of Education has decided to use remaining grant funds to continue providing services to veterans through May 2022. The state office for the Troops to Teachers program will be operational during this extension time.
- Mercyhurst University will continue to provide veterans with options for teacher certification at a 50% reduced tuition rate. There are currently 25 TTT participants enrolled.
- Temple University is continuing to provide services to TTT participants.

## **Mission:**

Using a holistic approach, the Health Promotion Committee will identify physical, behavioral health and other wellness service providers to foster relationships and build resource awareness among service members, veterans and their families across the commonwealth. Ongoing collaboration with federal, state, local government and community partners will facilitate and identify effective prevention and treatment approaches, share training and education resources and promote communication of these resources to Pennsylvania service members, veterans, and their family members to assist in reducing unhealthy behaviors and the number of suicides in Pennsylvania.

## Vision:

Our overarching vision is to see thriving service members, veterans, and their families across the commonwealth with zero suicides among those who have served our nation.



### Goals:

- 1. Continued provision of trainings such as: Mental Health First Aide (MHFA), Question Persuade Refer (QPR), and Applied Suicide Intervention Skills Training (ASIST). Trainings will occur through DMVA's regional program, 3 per quarter annually (1 per month based on region would be a minimum starting point).
- 2. Create 2 Fairweather Lodges annually.
- 3. Hold evidenced-based training annually providing a specific modality known to be an effective treatment for veterans, and continue collaborative MH/BH training summits in PA.



The Health Promotion Branch of **Service Member Family Support** has worked in collaboration with community resources to ensure our service members, who are community members 28 days out of the month, are able to recognize risk/warning signs and get the next level of care as needed.

#### Accomplishments and pending events FY 2021:

- Resilience and Engage Distance Learning **Sound Mind During Uncertainty,** 10 seats per class, 8 classes offered, 40 completions workshops currently suspended.
- Start Program by Living Works (ASIST creators) 1.5hour class, what intervention looks like (waiting on licensing, SFC Lopez working with South Carolina on this.)
- Applied Suicide Intervention Skills Training (ASIST) Since January 21, two of our ASIST T4Ts trained 41 members of their unit while being deployed. Another 55 Soldiers were trained here at FT Indiantown Gap. We have 1 more workshop currently scheduled 7-8 SEP with 25 students registered.
- Ask Care Escort-Suicide Intervention (ACE-SI) Since January 21 we conducted four classes training 46 Soldiers. We have 1 more class currently scheduled for 9 SEP with 20 students registered.
- Master Resilience Trainers, trained 12 in FY 21, projected another 2 for remainder of FY.
- Master Resilience Trainers, Level II Facilitators, trained 3 Soldiers in 21.
- Suicide Prevention/Resource event. These events focus on small group discussions and connectedness. Since July 2020 we meet w/18 units and personally spoke w/ 1500 Soldiers and leaders.
- Continued support of local community resource exchange and other military efforts.
- 5K Run for Life/Resource Event scheduled for 10 SEP @ Memorial Lake. Approx. 15 20 vendors & 150 soldiers to be reached.

#### Star Behavioral Health Providers Program (SBHP – PAARNG joined Dec. 2019)

The SBHP provides three levels of training (Tiers) for civilian behavioral health providers in your state and local communities who are interested in serving the military population, particularly NG members. SBHP offers a public online registry or listing that allows service members, their families, military behavioral health providers, military leaders, and others to easily search for trained providers in their areas. The goal is to **expand access by providing culturally competent, evidence-based behavioral health treatment through this training program.** Launched nearly 10 years ago, SBHP was developed as a partnership of the Indiana National Guard, National Guard Bureau, Indiana's Family and Social Services Administration, Center for Deployment Psychology (CDP), and Military Family Research Institute at Purdue University (MFRI).

- Offers free CE to providers
- Over 450 training workshops completed
- Has provided 142,000+ training hours
- Nearly 1,000 providers on the registry in approximately 20 States
- Workshops significantly increase BH providers confidence to treat service members and veterans
- Significant gains in participants' knowledge about military culture, treating military populations and evidence-based psychotherapies (EBPs).
- Monthly engagement calls between registered providers and PA ARMY National Guard to cultivate relationships between us, share resources and make connections.



#### Star Behavioral Health Program (SBHP) UPDATE:

- Since MAR21, three Tier 1, three Tier 2 and three Tier 3 trainings have been offered. Due to high volume of individuals on wait lists (over 100 each) to attend trainings, maximum capacity for attendees has increased from 175 to 200 individuals per training.
- A total of 610 individuals were trained this past quarter.
- Currently, all training opportunities are filled through September, but they hope to roll out the new training flyer for October-December trainings sometime in August.
- Training opportunities will decrease next year due to funding restraints.
- PA has 8 registry providers in which 5 came on board CY21.
- They have 51 Pennsylvania participants registered for upcoming trainings.
- Live in person trainings are still in the works it is anticipated that majority of trainings will still be hosted via Zoom next year, perhaps indefinitely.

#### **Federal Partnerships & Collaborative Efforts:**

- During the 3<sup>rd</sup> quarter of this fiscal year, VISN 4 CEPCs have established 9 new community coalitions, one per VISN site catchment area.
- A successful virtual 2021 DOD/VA Suicide Prevention Conference, involving many commonwealth participants, was held this past May.
- Currently moving forward with getting as many residential beds, as safely possible, open.
- VISN 4 continues to provide video-based MH treatment and is expanding face to face care options to meet veteran preference. In June, VISN 4 35% of mental health visits were face to face, up from 31% in May.
- Community-Based Interventions for Suicide Prevention (CBI-SP) continue to serve as a unifying model for all community-based efforts, throughout all national and community levels, in support of VA's Mission to end veteran suicide.
- VISN 4 continues to be an active and ongoing participant in the PA Governor's Challenge work groups and the NW PA Veteran Suicide Prevention/CDC Advisory group.

#### **Accredited, Veteran-Focused Competency Courses Available Online**

Community providers who treat Veterans are invited to take a variety of self-paced, accredited online courses, offered 24/7 through <u>VHA TRAIN</u> MISSION Act (MA) Curriculum, to help meet MISSION Act 131 and 133 competency standards. Sections 131 and 133 require VA to ensure that all community providers treating Veterans meet certain requirements regarding opioid prescribing practices and meet certain competency standards.

These courses available on VHA TRAIN MA provide training and resources in the areas of military culture, suicide prevention and other Veteran-related topics, equipping community providers with general knowledge about mental and physical health diagnoses commonly found in the Veteran population. Click <a href="here">here</a> for a flyer that can be used to locally promote these courses.

<u>Community Care Provider Opioid Safety Initiative</u> – This course was designed to build a collaborative effort between VA and non-VA care providers, to promote evidence-based management of Veterans with chronic pain, improve patient outcomes and decrease incidence of complications when prescribing opioids. No accreditation offered.

<u>Community Care Provider: A Perspective for Veteran Care</u> – This course offers an introduction for community providers to Veterans and diagnoses that are deemed more common in Veteran patients. Accreditations offered: AAPA, ACCME, ACCME, APA, ANCC, ASWB, NYSED SW and JA IPCE.

MISSION Act 133: A Core Training on Military Sexual Trauma (MST) for Community Medical Professionals – This course is designed to provide community medical professionals with brief training on key information related to the care of Veterans who experienced MST. Accreditations offered: ACCME, ACCME-NP, ANCC and JA IPCE.

MISSION Act 133: A Core Training for Military Sexual Trauma (MST) for Community Mental Health Providers – This course is designed to provide community mental health providers with training on key information related to the care of Veterans who experienced MST. Accreditations offered: APA, ASWB, NBCC and JA IPCE.

MISSION Act 133: Traumatic Brain Injury – This course is designed to provide community providers with general training and resources in the areas of military culture, traumatic brain injury, suicide prevention and other related topics. Accreditations offered: ACCME, ACCME-NP, ANCC, AOTA, APA, APTA, ASWB and JA IPCF.

MISSION Act Section 133: PTSD Course — This course gives community providers basic information on the diagnosis and treatment of PTSD. Accreditations offered: ACCME, ACCME, APA, ANCC, ASWB, NBCC, NYSED SW and JA IPCE.

Community providers must be registered in VHA TRAIN MA Curriculum with a National Provider Identifier (NPI number). Registration only takes a few minutes, and the benefits offered are immeasurable. A VHA TRAIN MA Curriculum account offers 24/7 access to hundreds of accredited courses on numerous subject matters in order to meet the learning needs of community providers caring for the Nation's Veterans. In addition, registered users have access to over 5,000 accredited courses in VA's main VHA TRAIN site. 

## **Department of Corrections (DOC)**

#### **Current Snapshot**

- As of July 1, 2021, DOC has 2,326 *verified* veterans in custody which represents 6.2% of the incarcerated population. These numbers are gathered through the Veteran Reentry Search Service (VRSS) through the VA. There are likely many more veterans within the DOC that have yet to be identified.
- There are five (5) Veteran Service Units (hereafter "VSU") within the department; SCI Dallas, SCI Houtzdale, SCI Mercer, SCI Muncy (female), SCI Phoenix.
- Current VSU statewide bed capacity is approximately 554 (330 filled)
- There are approximately 7,000 veteran employees within the DOC and Pennsylvania Parole Board (PPB)



## **Department of Corrections**

#### **COVID-19 Updates**

- COVID-19 continues to hinder veteran services within state facilities; however, state correctional institutions (SCIs) have allowed some programs and services, along with inmate visitation, to resume
- The VSUs are currently working to identify & place eligible veterans within their facilities back into the specialized units; however, they have been met with some resistance due to low morale and lack of program continuity during the pandemic
- Inmate transfers remain on hold for VSU placements at this time.
- DOC administration remains cautious during this "reopening period" as a 4<sup>th</sup> wave of COVID-19 now approaches



## **Department of Corrections**

#### **Agency Commitment to Veteran Services**

- Agency approved five (5) new Veteran Coordinator/Unit Manager Positions in April 2021; One Manager per VSU who will directly manage and promote veteran services within that unit/facility for all veteran staff/inmates.
- Veteran Manager Positions were posted in June and received an incredible amount of well-qualified candidate submissions
- As of August 1, 2021, interviews were completed in four of the five VSU facilities; three of the selected candidates are in the processing phase and one candidate began her new position at SCI Mercer July 26. 2021.
- Once all of the VSU Managers are officially hired, group trainings will commence in order to ensure program fidelity and open lines of communication between SCIs, DMVA, VA, and additional community resources specific to veteran needs.



## **Department of Corrections**

#### **Short-Term Agency Goals**

- Maintain and distribute the verified veteran's list to local coordinators on a quarterly basis
- Promote the Veteran Services initiatives to all incarcerated veterans and advocate for VSU placement in order to improve their reentry success
- Develop a plan to authorize VA approved contractors to enter state facilities for Compensation and Pension interviews/evaluations in order to ensure benefits are in place upon release
- Fill the VSU beds and establish waitlists for the veterans unable to immediately receive a bed due to max-capacity, behavioral issues, sentence status, or programming restrictions
- Train the newly hired VSU Managers and expand the Veteran Services provided to the inmates
  within the VSUs, in addition to the services provided to veteran staff members within the
  facilities



## **Department of Corrections**

#### **Long-Term Goals**

- Ensure that all VSU/VSOs are offering veteran-specific programming and reentry services with a measurable degree of consistency and uniformity
- Reexamine the VSU placement checklist to ensure that all veterans can benefit from support services
- Work with newly appointed VSU managers, along with Veteran service support agencies, to update current DOC policy pertaining to veteran services
- Open additional VSUs within state and county facilities
- Assist in the expansion of Veteran's Courts
- Create a means of measuring success rates of VSU/VSO reentrants while participating within the institution as well as recidivism rates under field supervision.
- Allow staff & inmates involved in VSU/VSOs to temporarily transfer to high-functioning VSUs in order gain insight and personal experience that can be shared and implemented when returning to their parent institution

- Reporting measurable outcomes (program success/recidivism rates) from state and county veteran service programs/units.
