#### **Goals/Initiatives**

- Increase awareness of services and supports for aging veterans and their families and caregivers among professionals within PA's Aging and Veteran Services networks.
- Safeguard Pennsylvania's aging veterans from abuse, neglect, exploitation, and self-harm.

#### **Updates**

- Geisinger Program Manager-Military and Veterans Affairs
  - Partner Geisinger with Commonwealth Agencies to increase awareness of available programs and reach another targeted audience
- Financial Exploitation Task force
  - PDA collaborating for education on contacting Social Security, LE training on protective service and required reporting
- Collaboration with Center for Combating Elder Financial Abuse
  - January 25<sup>th</sup> meeting held between DMVA, Aging Committee and CCEFA President. Topics discussed included:
    - Predator Fundamentals and Three Steps to Protect Vulnerable Elders,
       PA VETConnect, Veterans Poaching Scams

#### **Challenges/Barriers**

- Significant difficulty in getting LE to respond to requests for call backs/meetings.
  - Office of Attorney General and Temple University Collaborating on "Investigator's Toolbox" to provide law enforcement the tools needed to conduct such investigation for alleged financial exploitation
  - Reviewing current law enforcement training resources to evaluate how current training can be combined into a tool-box type protocol for investigating.

#### Goals/Initiatives

- Consider action regarding lack of warming shelters, emergency shelter beds, affordable housing, AND impacts of COVID-19
- Advocate for Coordinated Entry Access Sites at more VA Medical Centers and SSVF providers
- Uncover resources for National Guard/Reservists who do not qualify for SSVF or traditional veteran homeless programs and advocate for a streamlined referral process
- Collaborate with Women Veterans committee regarding solutions for women veterans experiencing homelessness
- Partner with Aging Committee to discuss housing instability of aging veterans and discuss ways to better communicate with long-term care industry
- Partner with Judiciary Committee to discuss veterans exiting incarceration who have been historically hard-to-place

#### **Updates**

- Legal Assistance workgroup has engaged with the PA Bar Association MVA
   Committee
- Engaging PennDOT leadership about connecting with homeless individuals who request a free ID card with a veterans' designation
- PA Homeowner Assistance Fund (PAHAF) applications open on Feb. 1, 2022
- HOME ARP Program \$78M available through DCED to assist with TBRA, affordable housing development, development of non-congregate shelter, etc.

#### PA CareerLink®

#### Goals/Initiatives

Serve veterans across 58 PA CareerLink® locations.

#### **Updates**

- State CY 2021 ... over 12,600 veterans served
  - ➤ 1,276 with SBEs receive intensive services through DVOP
  - ➤ Served through JVSG, Wagner-Peyser, WIOA Title I, and Trade workforce programs
- 3 DVOPs and 1 LVER less than for our report last year

#### Challenges/Barriers

■ Foot traffic across PA CareerLink® offices is down, although BWPO staff have been in the offices since July 2021.



#### Office of Administration – Veterans Hiring

#### Goals/Initiatives

• Hire Veterans into state government ... PA Military Code 51, Veterans' Preference

#### **Updates**

- State Fiscal Year 2020-2021 ... over 1000 veterans selected
  - > 16% of commonwealth hires
  - ➤ Only 4% of PA's working age population are veterans
- Relatively stable over 3 years of data ... anticipate slow decline

#### Challenges/Barriers

- Act 102 of 2020 ... clarifying language, experience & training as earned benefit
- SB849 "Disability Tweak" passed Senate in Nov '21, pending in House



#### **HIRE Vets Medallion Program**

#### Goals/Initiatives

- Recognition Program for private business
  - ➤ Recruiting, Hiring and Retaining Vets

#### **Updates**

- 2020/2021 Participation in PA
  - ➤ 29 recognized by DoL (6<sup>th</sup> most in US)
    - ➤ 9 small employer platinum
    - ➤ 15 small employer gold
    - > 5 medium employer gold

#### Goals/Initiatives

- Improve outreach efforts to veteran staff within the Department of Corrections (DOC) through collaboration with DMVA
- Identify veteran inmates within the DOC at classification in order to place them in veteran designated facilities
- Increase the amount/availability of veteran-specific trainings for employees
- Promote/advocate for the creation/enhancement of veteran courts/tracks
- Offer training to courts on evidence-based practices and motivational interviewing
- Promote criminal justice careers to students and job seekers



#### **Updates**

- Committee welcomes new member Troy Edwards. Troy is the Veteran Service Unit Manager at SCI Dallas as well as a 21-year Veteran of the United States Navy
- DMVA working on plan to engage DOC staff veterans in every institution
- DOC working on new classification tool that will identify inmate veterans and allow for strategic placement along with a more accurate statewide veteran inmate database
- DOC working on mechanism to ensure that PA VETConnect tool can be accessed by all staff and inmate veterans within the agency



#### **Challenges/Barriers**

- Pandemic restrictions continue to affect visitation, workshops, presentations for the DOC veteran population
- Working with IT departments in order to increase virtual capabilities for targeted population
- Limited knowledge regarding process necessary to advocate for/expand veterans courts/tracks within the commonwealth
- Pandemic travel restrictions limit the ability to provide interagency outreach or make connections with community organizations to promote CJ careers



# What PID Regulates

The Pennsylvania Insurance Department regulates fullyinsured, commercial products

# Mental Health and Addiction Equity Act of 2008 (MHPAEA)

"Federal law that generally prevents group health plans and health insurance issuers that provide mental health or substance use disorder (MH/SUD) benefits from imposing less favorable benefit limitations on those benefits than on medical/surgical benefits"

# Patient Protection and Affordable Care Act (2010)

Mental Health and Substance Use Disorder Coverage

# Individual and small group

 Mental health and Substance use disorder benefits must be covered (as described in the Pennsylvania Benchmark Plan)

# Fully-Insured large group plans

 Mental Health and Substance use disorder benefits may but are not required to be covered.

#### Self-funded plans

 Mental Health and Substance use disorder benefits may but are not required to be covered.

# State Requirements

Act 106 of 1989

40 P.S. § 908-2

 Establishes minimum standards for coverage of substance use disorder coverage for inpatient detoxification, nonhospital, residential, and outpatient services

Act 150 of 1998

40 P.S. § 764g

- Requires coverage of 9 "serious mental illnesses" and establishes minimum standards for inpatient and outpatient services
- Schizophrenia, bipolar, obsessive-compulsive disorder, major depressive disorder, panic disorder, anorexia nervosa, bulimia nervosa, schizoaffective disorder, and delusional disorder

Act 14 of 2010

40 P.S. §§ 908-11-908-16

- Commonwealth's parity law
- Ensures parity is applied consistently across health insurance products

Acts 89 and 92 of 2020

40 P.S. §§ 604.1-B and 604.2-B

- Requires verification of parity analysis
- Permits PID, providers, and policyholders to request documentation pertaining to parity analysis

# Pennsylvania Benchmark Plan – Behavioral Health

Baseline of Essential Health Benefits for health insurance plans sold in Pennsylvania

**Covered Services (In-Network Providers and Facilities)** 

#### Mental Health

#### **Outpatient**

- Psychiatric visits and consultations
- Individual and group psychotherapy
- LCSW visits
- Masters Therapist visits
- Electroconvulsive therapy
- Psychological testing
- Psychopharmacologic Management
- Psychoanalysis

#### **Inpatient**

- Psychiatric visits and consultations
- Individual and group therapy
- Electroconvulsive therapy
- Psychological testing
- Psychopharmacologic management
- Diagnostic Services

#### \*IOP and Partial Hospitalization must be approved by the Health Benefit Plan

#### Substance Use

#### Outpatient

- Diagnostic services
- Services provided by provider on staff
- Rehabilitation therapy and counseling
- Family counseling and intervention
- Medication management and use of equipment and supplies provided by the treatment facility or residential treatment facility

#### Inpatient

- Medical treatment of alcohol or drug abuse and dependency including detoxification
- Non-medical treatment such as vocational rehabilitation or employment counseling
- Lodging and dietary services
- Diagnostic services
- Services provided by a staff physician, psychologist, LPN, and/or a certified addiction counselor
- Rehabilitation therapy and counseling
- Family counseling and intervention
- Prescription drugs, medicines, supplies, and use of equipment by the facility

# Pennsylvania Insurance Department's Role

- · Regulatory oversight of insurance products sold in Pennsylvania
  - · Approve products filed, forms, and rates
- Market Conduct Exams
  - · Statutorily required
  - · Retroactive exam of past 5 years
- · Enforcement actions
  - · Exam reports are publicly available
  - Corrective action examples
    - \$1,000,000 penalty
    - \$800,000 educational campaign
    - · Restitution to consumers
