






DISABLED VETERANS TAX EXEMPTION PROGRAM

Call to Order Chairman Edgar Burris

Chairman Burris introduced Southeastern Veterans' Center Commandant Rohan Blackwood, Deputy Commandant Mildred Butler and Executive Secretary Kathy Knob-Hardy and thanked them for everything they did on behalf of the SVC and the excellent tour of the facility. Commandant Blackwood thanked SVC members for choosing the SEVC. He offered anyone who had missed the morning tour a tour following the meeting; the staff welcomes tours because they are proud of what they do.

Oath of Office Brig Gen Regan

General Regan administered the Oath of Office to the following newly appointed Pennsylvania State Veterans Commission members:

• Matthew Zamosky-PSACDVA, Robert Ziltz-MCL, Gary Stopyra-DAV, Thomas Hanzes-VFW, James Vollrath-TAL.

Awards/Recognition

Chairman Burris presented a Certificate of Appreciation to outgoing SVC member Mr. William Kelley for his dedicated and unwavering service to the SVC. Certificates of Appreciation were prepared for the following outgoing members not in attendance- Misters: Desrosiers, Hanke, Fuhrman, Kennedy, Foresman and Powell. They will have their awards mailed to them.

Approval of the April 6, 2018 Meeting Minutes

Chairman Burris asked if there were any questions/comments regarding the April 6th minutes, none were raised. Chairman Burris moved to have the minutes approved.

Motion: Mr. Zamosky motioned to approve the minutes.

Second: Mr. Clooney Seconded the motion.

The body agreed, motion carried.

Military Update Brig Gen Regan

General Regan reported there currently are 720 PANG soldiers and airmen stationed all over the world. There are 500 PANG members stationed throughout the Middle East who are expected to return in December 2018. Everyone is safe and sound. CSM Buchanan had recently flown over to the Middle East to check on the PANG men/women. He reported they are "hanging in there, as expected." General Regan offered to answer any questions, but none were asked.

VISN 4 Dr. Michael Adelman

Dr. Adelman noted that SVC members had received his slides with updated access, wait time, trust and community care data as a read-ahead. Dr. Adelman addressed two questions/issues from the 1 June meeting: First question/issue regarded medical records from non-VA physicians being entered into the MY HealtheVet for Veterans to access.

• Currently, outside records are not viewable by Veterans through My HealtheVet. However, Veterans can request a copy of their records. He said when the facility community care coordinators set up non-VA appointments, they should let the provider know to send the resulting medical records to a secure fax machine in the community care office. Once processed, the records are scanned into the Vista Imaging which is part of the Veteran's electronic health record but is not accessible in My HealtheVet. If a VA provider reviews the records received from a community provider, and creates a VA Clinical note regarding those records, that will be available in My HealtheVet. To learn more about the sharing of electronic records, including how to sign up and what non-VA providers are enrolled, visit www.va.gov/VLER/.

Second question regarded the use of wrist bands displaying the full name and social security number of the Veteran.

• The VA is required to use social security numbers because they don't have a system to assign Veterans a unique medical number as a form of identification. This system is used as a unique identifier. The full social security number plays an important role in promoting patient safety by supporting accurate, direct and efficient patient identification. The Joint Commission requires two human readable unique identifiers, thus the use of the full name on the wrist band as well. This system reduces errors and ensures appropriate electronic entry and reduces medication being issued to the wrong patient. However, the VA has recognized that a OneVA Unique Identifier is necessary to provide a single/unified view of the Veteran and dependent data across all information systems and processes. VHA-level initiatives are being considered to enable the creation and use of a OneVA Unique Identifier for Veterans and dependents as an alternative to the use of the social security number as the primary identifier. This endeavor to change over to a OneVA Unique Identifier will take time to develop and will not come without significant challenges due to the complexity of the information system.

Dr. Adelman provided the following Leadership Update:

- Karin McGraw, director of VA Pittsburgh Healthcare System, and Daniel Hendee, director of the Crescenz VA Medical Center in Philadelphia, have both announced that they will retire at the end of the year. The process to recruit replacements has already begun.
- Since July 9th, Dr. Jo-Anne Suffoletto has been detailed to VA Butler Healthcare as interim chief of staff. Dr. Suffoletto is the associate chief of staff for education and innovative learning as well as the medical director of the simulation program at VA Pittsburgh Healthcare System.

Dr. Adelman noted the following leadership changes:

- 1. Lebanon's Camp Hill VA Clinic currently located at 25 North 32nd Street is being relocated to a site 4.1 miles from the current clinic. VA Pittsburgh Healthcare Systems' Fayette County VA outpatient Clinic currently located at 635 Pittsburgh Road in Uniontown is being relocated to a site just a few doors down from its current location in the shopping plaza.
- 2. The VISN/4 has relocated its office from North Shore Drive near downtown Pittsburgh to the H.J. Heinz campus of VA Pittsburgh Healthcare System, which is in O'Hara Township near Aspinwall.

Ouestion/Comments:

Mr. Hudzinski enquired as to why VISN/4 had reduced funding for the homeless Veterans in the Wilkes-Barre/greater Lehigh area and for Support Services for Veterans Families. He noted that it was his understanding the funding for SSVF in that region was reduced by \$350,000.00 last year. Dr. Adelman said he wasn't sure the funding was reduced but would investigate it and report back. Dr. Adelman did state there were some service changes which might have impacted the perspective of the funding. However, Dr. Adelman stated that there never is a reduction in funding for homeless Veterans.

Mr. Jeffrey White commented that he didn't understand how a "low level bureaucrat" could arbitrarily reduce the personal care stipend of his daughter-in-law from a level 2 to a level 1. Dr. Adelman stated to Mr. White he should follow the appeal process.

Mr. Matthew Zamosky stated certain VAs are requesting Veterans to fill out data sheets ahead of time. Mr. Zamosky asked if the data sheets are designed for determination of eligibility. Dr. Adelman stated it was a staff

oversight. The data sheet is designed to speed up information for clinical appointments and not for determination purposes. He said the oversight was corrected.

OLD BUSINESS

Bylaws Discussion Chairman Burris

Chairman Burris stated that since the wrong copy of the Bylaws had been sent out to the members there will not be a discussion or vote. The correct version of the Bylaws was included in the recent read-ahead. The discussion and vote on them will occur at the next meeting. He noted Mr. Peterovich will discuss Bylaws during his committee report.

DMVA Chief Counsel Ms. Elizabeth Pettis

Ms. Pettis was not present, there weren't any comments or questions.

DMVA Policy, Planning & Legislative Affairs

Mr. Gilbert Durand

Mr. Durand was not present, there weren't any comments or questions.

DMVA Bureau of Veterans' Homes

Mr. Andrew Ruscavage

Mr. Ruscavage thanked the SVC members for choosing the Southeastern Veterans Center as their meeting location this month. He reported all BVH licensures are up to date and in the green status. The SEVC currently has a new maintenance building under construction which will house both maintenance and housekeeping. The bottom floor at SEVC will be converted to an Adult Day Care facility, the concept is currently in the design phase and will most likely take two years before it will be completely operational. Mr. Ruscavage noted the PA DMVA-BVH will be the fourth state in the U.S, to have Adult Day Care for Veterans. Mr. Ruscavage briefed on changes at the Delaware Valley Veterans' Home which will undergo an entire renovation. At DVVH personal care patients have all been moved to the other Veterans' homes. Once the renovations are finished DVVH will be a skilled nursing facility. Renovations will begin in November 2018.

Questions/Comments:

- Mr. Hudzinski recommended amending the licensure chart on the DMVA website. He recommended removing the personal care and domiciliary services listing for Gino J. Merli Veterans Center and the Southwest Veterans' Center as they will be vacated. Mr. Ruscavage agreed to black them out.
- General Weller requested Mr. Ruscavage explain the reason for moving DVVH to solely skilled nursing, the initiative to address more personal care to Veterans who live in rural areas and who will staff these protype Veterans' homes. Mr. Ruscavage reported that the Philadelphia area had a long waiting list of Veterans who are acutely ill and needed skilled nursing; so, it was decided to make DVVH a skilled nursing facility to address the issue. The need is that great for skilled nursing care that considerations are already being given to expand the facility to allow for more beds. Mr. Ruscavage said the initiative to extend care to Veterans in rural areas would build partnerships between DMVA-BVH and county homes or other nursing facilities in these rural areas. The proposal is designed to identify the need and level of Veteran care in targeted areas, identify a county home/nursing facility that would be willing, and would need the financial assistance, to engage in a partnership allowing the BVH to operate independently within their facility. For example, the BVH would take over a floor within the facility, staff it with BVH state employees and provide the same high level of quality care to the Veteran that he/she would receive if the Veteran were at any of the BVH facilities. Mr. Ruscavage noted the VA is working diligently with the DMVA-BVH on this initiative and the concept has reached the planning stages that now require lawyers to review operational procedures, proposals and subsequent contracts.
- Mr. Hudzinski asked how the proposal would work with county homes that are contracted out to private enterprises. Mr. Ruscavage said DMVA-BVH contracts would be written in such a manner to maintain the same level of care and standards that Veterans' receive at the six state homes.
- Mr. Hudzinski asked General Weller to brief the SVC members on the LIFE program and Adult Day Care as he did at the PWVC. General Weller said he didn't have a lot of information on the LIFE program. He said the folks who run the LIFE program will hold a hearing with the Veterans Affairs and Emergency Preparedness Committee on September 26th. He said BVH doesn't have any programs of inhome care at this time. General Weller said it's his understanding there is legislation out there that may

- impact increased funding for Adult Day Care. He noted the DMVA-BVH has a higher PPD ratio than the state average and the ratio is based only on hands-on care givers. General Weller said Adult Day Care will cost something, nothing is free and that's the point they will have to drive home to the budget office and the legislators.
- Mr. Petrovich asked regarding the proposal to partner with county homes, how many and where? Mr. Ruscavage said they are aware of the need in the Lehigh and South-Central areas and have reviewed a previous study. However, they are not at the point where exact numbers can be discussed. General Weller said they have been discussing county partnerships and collecting information for a couple of years and needed to figure out the best way forward, no matter which way forward it will cost money. He wants to get the proposal documented with due diligence, put it in front of the decision makers and have a decision in the next three or four months.

Mr. Ruscavage reported that VISN/4 and BVH are moving forward with telemedicine making routine checkups easy for Veterans. He said it should be operational in all facilities relatively soon.

DMVA PIRO Mr. Joel Mutschler

Mr. Mutschler said it was an honor for him to serve the Veterans of Pennsylvania. He pointed out two key issues. First, regionalization was moving forward in the process of connecting with non-profits throughout PA and then connecting resources between non-profits and VSOs. The second, was working through the VSOs to concentrate all their efforts in a team concept. He said he would like to hear from all the VSOs of what they think and need to make a difference.

DMVA Services & Programs

Mr. Brian Natali

Mr. Natali stated all materials were presented in the read-ahead, asked for questions, but none were asked. He asked for a vote.

Approval of Programs Reports

Motion: Mr. Zamosky made a motion to approve the programs reports.

Second: Mr. Cyprian seconded the motion.

The body agreed, motion carried.

DMVA Outreach & Reintegration

Mr. Chip Gilliland

Mr. Gilliland was not present. Mr. Mutschler asked if there were any comments or questions regarding the materials in the read-ahead. There weren't any.

Motion: Mr. Hanzes made the motion to approve the Outreach and Reintegration report.

Second: Mr. Taylor seconded the motion.

The body agreed, motion carried.

SVC Bylaw Committee

Mr. Samuel Petrovich

Mr. Petrovich began by explaining why the Bylaws were not going to be voted on today, the version of the Bylaws sent out in June were incorrect. The correct version was only sent out in the recent read-ahead packet and members needed more deliberation time. He provided each member with his email address and invited them to comment on the Bylaws. He said, depending on the comments, he may call a committee meeting to address those comments.

Questions/Comments:

• Mr. Jackson stated that in the May 9th version [the correct version] of the Bylaws it has the SVC subordinated to the TAG; he didn't believe that is correct and needed to be changed. He further stated the section addressing members-at-large needed to be tweaked. Mr. Jackson wanted the section, stating SVC members need permission from the TAG or DMVA-PPL before going to legislators as SVC representatives, removed. The last issue Mr. Jackson spoke about the inability of the SVC to make changes to amendments to the Bylaws without TAG approval. Mr. Petrovich stated the section addressing members-at-large was strictly under the purview of the Governor's Office and once the decision is made, there is nothing the SVC can do about it.

SVC Act 66 Committee Mr. Gary Stopyra

Mr. Stopyra did not have a committee report.

Questions/Comments:

• Chairman Burris said he sent an email to the Act 66 Committee suggesting that since it took so long to get the \$500,000.00 maybe they could ascertain a method to request a little less but without going so long between increased funding periods. Mr. Petrovich said it was his belief that the \$500,000.00 was the amount that was to be put into the budget as an increase each year over a five-year period. He noted the Act 66 Committee of the PWVC is now working with the state legislature to have the \$500,000.00 increase each year in the budget and if the SVC Act 66 Committee does it differently, it would be counterproductive and confusing. Mr. Hudzinski supported Mr. Petrovich's statement, adding it was former Adjutant General Craig who agreed with the five-year \$500,000.00 per year increase in funding.

- Mr. Hamp explained that the current situation with the \$500,000.00 in the budget has now become a cost to carry item and not listed as an increase in the budget each year. Mr. Hamp agreed with Mr. Hudzinski regarding Adjutant General Craig; however, what the Act 66 Committee took downtown was a one time increase as a cost-to-carry item. Mr. Hudzinski remarked that now they must argue each year for more money, saying he didn't know where the SVC wanted to go with this, but we need to press for more money. Mr. Petrovich pointed out the Act 66 Committee who took the one-time funding increase downtown was the PWVC Act 66 Committee. The SVC Act 66 Committee was only formed last year. He said the SVC Act 66 Committee needs to have continuity with the members who serve on it from year to year and both Act 66 Committees must show unity. He called on the Chairman to have the SVC Act 66 Committee work hand in hand with the PWVC counterpart.
- Chairman Burris thanked Mr. Petrovich for his comment and agreed with having the two committees work in a unified effort, noting it will bring more clout for Veterans.
- Mr. Jackson said it was his understanding that last year an agreement was reached where the PWVC Act 66 Committee would lobby at the capitol for additional funding and the SVC Act 66 Committee would oversee the management of the funds. He then asked "how does the SVC get good reporting" and how do participants manage their funds. There is no agreement among the Act 66 Committees on how to use the funds or a structure to address it. Mr. Watson suggested the same members who serve on the SVC Act 66 Committee should also serve on the PWVC Act 66 Committee to bring uniformity. Chairman Burris complimented everyone for a good committee discussion and requested the names of the PWVC Act 66 Committee members. He said he believed the key was communication between the SVC and the PWVC.
- Mr. Hudzinski opined that he can see a confluence of events occurring here today. If the SVC is viewed as only an advisory council and beholden to and having to obey the TAG it will be limited in its effectiveness. However, if the SVC can operate as an independent body, as does the PWVC, then overall the SVC will acquire more cooperation and benefits for Veterans.
- General Weller explained, regardless of who goes downtown requesting funding increases, it remains the sole decision of the TAG on whether he puts an increase for funding in the budget. He then offered to approach the TAG to determine if he would be interested in doing so this year. Mr. Hudzinski suggested the SVC present argument to the TAG to include increased funding in the budget. General Weller said for the TAG to act, the TAG will need a recommendation from the SVC in a proposal and vote format. Mr. Hudzinski called on Chairman Burris to act.
- Mr. Burris said that, based on all the discussion he heard, action will need to be taken to decide which Act 66 members should also serve on the PWVC Act 66 Committee. Mr. Burris stated a motion with a vote should be taken on requesting the TAG to place a \$500,000.00 increase in funding for Act 66 each year for the next four years.

Motion: Mr. Vollrath made the motion to request that the TAG increase the funding.

Second: Mr. Hudzinski seconded the motion.

The body agreed, motion carried.

SVC RETX Committee Mr. Matthew Zamosky

Mr. Zamosky said he did not have a report to present at this time.

Ouestions/Comments:

• General Weller requested the committee work with the DMVA-PPL to focus on one bill that everyone likes which can get across the finish line. Mr. Zamosky said he reviewed almost all the data given to him from the previous committee chair. He will soon set up a teleconference with the other committee members and include the DMVA-PPL representative.

SVC Legislative Committee

Mr. James Vollrath

Mr. Vollrath did not present a report. Instead, he briefly outlined what his committee would be doing in the future. Mr. Vollrath said his committee will align their agenda with the PWVC Legislative Committee and continue what his predecessor did "piggyback off of the PWVC." Mr. Vollrath said he will have a report for the October 12th meeting. Chairman Burris called on Mr. Vollrath to acquire the names of his counterpart committee members with the PWVC to build a strong corroborative union.

SVC Pensions & Relief/Grave Marking/State Military Cemetery Committee

Mr. John Brenner

Mr. Brenner was not present. Chairman Burris asked if there were any questions, comments or discussion. Nothing was raised.

NEW BUSINESS

December 7 Date Discussion

Mr. Ed Burris

Chairman Burris informed the members, when he held a meeting with the new incoming members a discussion ensued regarding moving the SVC meeting on December 7th (Pearl Harbor Day) because so many VSOs hold events on that day. A brief discussion occurred, Mr. Vollrath then stated "what better day to do our business for Veterans than on Pearl Harbor Day." Chairman Burris moved for a motion to keep December 7th as the meeting date and called for a vote.

Motion: Mr. Vollrath motioned to keep the SVC meeting as scheduled.

Second: Hudzinski seconded the motion.

The body agreed, motion carried.

*Mr. Hudzinski requested to reopen new business at the end of the guest speaker's presentation. Chairman Burris granted permission.

Mr. Hudzinski presented two motions in proposal form addressing the implementation of Act 71/Senate Bill 1037 and the maintenance of Veterans preferences. Mr. Hudzinski's concern was Act 71 wasn't being properly executed, he wanted the SVC to act as an oversight of the DMVA regarding Act 71. He wanted to establish a good reporting system with only DMVA data at this time.

*Motions below are directly and accurately copied from Mr. Hudzinski's submitted notes to Chairman Burris.

Motions:

- 1. To monitor if the DMVA is dutifully applying Veteran's preference under Act 71 of 2018.
- The DMVA report each SVC, using NEOGOV data provided by its OA Human Resources Center, the veterans hiring percentage by major occupational group and the hiring rate for each of them after dividing into two categories: civil service and non-civil service.

Question/Comments:

Chairman Burris asked for questions, comments and discussion. There were none. He put the motion up for a vote.

Motion: Mr. Hudzinski put his motion forth.

Second: Mr. Vollrath seconded the motion.

The body agreed, motion carried.

2. To assist in assuring the SVC our state Veterans homes are properly staffed under Act 71 2018.

- The DMVA determines its critical occupations (jobs) necessary to nursing home and secure portion of the operation.
- From this list, DMVA reports for each home and in total for the five critical occupations with the most vacancies, using NEOGOV data provided by its OA Human Resources Center for select criteria.
- (1) the number of positions required for the full staffing.
- (2) the number of positions open.
- (3) the median and average turnover rate.
- (4) the median and average days from date of vacancy to date of job announcement.
- (5) the median and average days from start of job announcement to end of job announcement.
- (6) the median and average days from end of job announcement to date of job fill.

Ouestions/Comments:

• Mr. Jackson immediately moved to second Mr. Hudzinski's motion; however, before a vote could be taken Mr. Taylor asked what the SVC intended to do with the collected data. Mr. Hudzinski said the intention was to determine how Act 71 was progressing and identify any problems. He further stated. that the motions were intended to address a decade-old problem with hiring Veterans. Mr. Hamp said all those were good points and the DMVA is currently working on the data requested. He reported it will take a little time to build a complete data stream and network flow which is necessary for a proper analysis. Mr. Hamp informed the members that doing this type of analytical reportage will put a burden on the already overloaded workforce; he then requested the members to give their full support when the DMVA asks for more manpower. Mr. Hudzinski said it was not his intent to find fault and the purpose is to ensure the proper care of the Veterans and have the SVC act in an investigative capacity. Mr. Burris called for a vote on the motion.

Motion: Mr. Hudzinski put his motion forward.

Second: Mr. Jackson seconded the motion.

The body agreed, motion carried.

Guest Speaker-Easterseals

Mr. Mathew Ernst

Mr. Ernst provided the members with a brochure and accompanying materials describing what his organization does for military families.

- Mr. Ernst briefed that in 2010 Easterseals wanted to expand their efforts beyond helping disabled people to include special needs groups. It was determined they should focus on an underserved pocket group which led them to military families. They decided they could best serve the military families by putting their efforts into weekend and summer camps for children of military families. The camps have tailored designed programs for the children, such as art, archery and even falconry. The camps also provide a little relief for the parent(s)/caregivers. The camps bring children together from across the Commonwealth. He said right now one of their major challenges is they only serve a small portion of that targeted group of children, they want to expand their programs.
- Mr. Ernst briefly touched on the programs that Easterseals has for Veterans with disabilities; such as specialized water skiing, rock climbing and other challenging programs.
- Mr. Ernst said Easterseals does not charge military families. They have partnership sponsors and are always exploring new revenue streams. He mentioned the American Legion and VFW are participants.

Questions/Comments:

• General Weller asked if anyone in the room would be interested in speaking with Mr. Ernst regarding any possibilities of providing assistance. General Weller advised Mr. Ernst to hand out his card to the members. General Weller then asked Mr. Ernst if Easterseals was aligned with the Combined Federal Campaign and SECA. Mr. Ernst said not at this time but agreed to explore it.

SERVICE ORGANIZATAION UPDATES

Service Update – Veterans of Foreign Wars

Mr. Thomas Hanzes

Mr. Hanzes reported the VFW Headquarters is in Harrisburg, PA. In June 2019 the VFW will celebrate its 100th Convention to be held in Erie, PA. He said the VFW has 450 posts and 75,000 members divided into 24 districts throughout the Commonwealth. The VFW supports 29 VSOs strategically located to assist Veterans with any help they need, or claims made. There are 250 VFW Auxiliaries with 35,000 members. He noted the VFW's current issues are gaming, the non-smoking exemptions, (55 posts are now non-smoking), and low membership rolls that all service organizations are experiencing. He suggested all the organizations should work in a collaborative manner to address shrinking membership. Mr. Hanzes closed with a quote from a college commencement speech, "If you don't remember anything from being here- remember to give back, it makes you a winner" He said everyone at the meeting were "givers."

Service Update - Catholic War Vets

Mr. Nicholas Taylor

Mr. Taylor reported he was assigned the designee for Commander Wright who had an emergency. Mr. Taylor reported the CWV had recently held its 83 National Convention in Pittsburgh, PA and they decided to move their headquarters in Alexandria, VA back to the CWV's birth place at the Church of the Immaculate Conception, Astoria, NYC. He was proud to announce the CWV will have the honor of the annual laying of the wreaths at Arlington Cemetery in 2019. He said following the ceremony a reception will be held at the Fort Myers Officers Club.

Service Update – Jewish War Veterans

Mr. Sanford Silver

Mr. Silver was not present.

Service Update – American Veterans

Mr. Paul Shipley

Mr. Paul Shipley reported that Commander Elliot had sustained a heart attack in August at the end of the AMVETS National Convention in Orlando, FL and was medically prohibited from participating today. However, Mr. Elliot expressed through Mr. Shipley that he will have a report for the October 12th meeting.

Good Of The Order/Announcements

Mr. Taylor briefed the members on the outstanding low-vision program the Lebanon VA is providing for our Veterans. He related a testimonial of a CWV member who attended the Lebanon VA low-vision program, how it changed the member's living conditions and vastly improved the quality of his life.

Mr. Petrovich announced the passing of Carmen DeSanti who was described as a man who did "great things" for Veterans. He informed the members he has the funeral arrangement schedule and those interested in attending can get the details from him.

Mr. Vollrath announced the American Legion will hold a ceremony on September 21st in the Wormleysburg area for POW/MIA.

Chairman Burris announced the guest speaker for the October meeting will be Mr. Saheed Hakim Sims, a contract employee with PennDOT. Mr. Sims will present on how he can assist Veterans with starting a business and establishing a business plan.

Health Net Federal Services Contract Close Out Overview For Veterans

The Department of Veterans Affairs (VA) contract with Health Net Federal Services (HNFS) is ending on **September 30, 2018**. HNFS is the third-party administrator for the eastern region of the Veterans Choice Program (VCP) and Patient-Centered Community Care (PC3) networks. When the contract with HNFS ends, VA will take over all activity previously performed by HNFS. VA will work with Veterans, community providers, and VA staff to transition care coordination from HNFS to VA as seamless as possible.

The end of VA's contract with HNFS does not affect VA's contract with TriWest Healthcare Alliance, which administers the western region of the VCP and PC3 networks. No immediate action is needed on your part. However, if you are requesting care in the community, please contact VA to coordinate all care after **September 30, 2018.**

Distance Eligible Veterans

If you are a Distance Eligible Veteran (located outside of 40 miles of the nearest VA medical facility) and need to schedule an appointment in the community after **June 30, 2018**, please contact VA for authorization and care coordination at the numbers listed below.

Frequently Asked Questions

1. Why is the contract with HNFS ending?

VA's contract with HNFS is scheduled to end on September 30, 2018 per the contract agreement.

2. Is the VCP program ending?

The VCP program will continue but the PC3 network will be discontinued on September 30, 2018 for Veterans in the HNFS regions.

3. How do I contact VA to obtain care after September 30, 2018?

All care delivered after September 30, 2018 will be

coordinated through VA. The VCP customer service lines will remain active and open during normal business hours and can be reached at 1-866-606-8198 (VCP). PC3 customer service lines will remain active and open during normal business hours through September 30, 2018 and can be reached at 1-800-979-9620 (PC3).

4. What happens after September 30, 2018 if I already have an appointment scheduled through HNFS?

HNFS will be issuing updated authorization letters to Veterans and providers with authorizations that extend beyond the contract expiration date to reflect an end date of September 30, 2018. Existing appointments under the HNFS contract must be completed before the end of the contract. Appointments after September 30, 2018 must be coordinated by a VA staff who will work together with your community provider to ensure a seamless transition for care authorization, coordination, billing and payments.

5. Do my providers need to submit my PC3 or VCP claims by September 30, 2018, to be paid for services rendered?

HNFS will continue to process claims after the September 30, 2018 contract end date. Claims for services on or after October 1, 2018 will be coordinated directly between your community provider and VA. This information has also been communicated to your community provider.

6. Who do I call if I have questions about appointments, authorizations, or billing?

The VCP customer service lines will remain active and open during normal business hours and can be reached at 1-866-606-8198 (VCP). PC3 customer service lines will remain active and open during normal business hours through September 30, 2018 and can be reached at 1-800-979-9620 (PC3).
